1. RULES

1.1 The regatta will be governed by the rules as defined in *The Racing Rules of* Sailing (*RRS*) for 2021 -2024 and the *Weta Class North American* (WCNA) rules.

2. ADVERTISING

2.1 Boats may be required to display advertising chosen and supplied by the organizing authority.

3. ELIGIBILITY AND ENTRY

3.1 The regatta is open to all Weta Class Trimarans whose skippers are paid Weta Class members.

3.2 Eligible boats may enter by remitting the entry form together with the required fee.

3.3 Registration shall be completed electronically.

3.5 There will be two classes of racing: single-handed and double-handed. Two valid entries will constitute a class.

4. FEES

4.1 Entry fees are as follows: Single-handed class - \$175.00, Double-handed class - \$225.00.

4.2 Fee includes Regatta Apparel (Swag), Friday Dinner & Keg, Sunday Burgers & Dogs after racing.

- 4.3 Extra social tickets are available for \$30 per person.
- 4.4 Brown-bag lunches are available for purchase each day, \$7 per person.

6. VHF RADIOS

6.1 The Race Committee may use VHF radios to inform competitors of safety information and to hail boats that are on-course side of the starting line (OCS) at the start and general information to assist in the management of the event. No transmissions will be allowed by any competitor while on the water.

7. MEASUREMENTS

7.1 Sail measurements and boat weighing will <u>not</u> be conducted at FWYC.

7.2 Measurements required by class rules shall be the responsibility of the WCNA Association.

8. SAILING INSTRUCTIONS

8.1 The sailing instructions will be available electronically via the race website. Copies will be available at the regatta headquarters.

9. VENUE

9.1 Regatta headquarters will be the FWYC, 180 Ferry Road NE, Fort Walton Beach, Florida 32548.

10. THE COURSES

10.1 The racing area will be east of FWYC on the waters of the Choctawhatchee Bay.

11. PENALTY AT THE TIME OF THE INCIDENT

11.1 Rule 44.1 is changed so that the Two-Turns Penalty is replaced by the One-Turn Penalty.

12. SCORING

12.1 The Low Point System of Appendix A will apply.

12.2 Three (3) races are required to be completed to constitute a regatta.

13. PRIZES

13.1 Prizes will be awarded to the top three boats in each fleet and first overall.

13.2 The WCNA will present the Florida Championship Series awards.

14. DISCLAIMER OF LIABILITY

14.1 Competitors participate in the regatta entirely at their own risk. See RRS Rule 4, Decision to Race. The Weta North America Class Association and the Fort Walton Yacht Club will not accept any responsibility for material damage or personal injury or death sustained in conjunction with or prior to, during, or after the regatta.

15. COVID 19 POLICIES AND PROCEDURES

15.1 Due to COVID-19, this Regatta may be cancelled or postponed.

15.2 All participants (skipper and crew) are required to sign and return the FWYC Event Waiver before the first race of the Regatta.
